All underground utilities such as water, gas, and sewer connections are to be terminated and sealed at the street right of way and the work shall include the removal of all buried pipes and footings for each parcel. Lots shall be left clean and full of debris and include trimming of overgrowth, bush hogging, stump/dead tree removal, vine removal and leveling with clean fill and seeding. All materials from the sites shall be disposed of properly in accordance with all regulations. Bidders shall be responsible for all environmental assessments, testing, monitoring and/or disposal.
