SCOPE OF WORK

Chester Fire Department Emergency Generator (Station 1)

Scope of the work: Materials and Labor for existing building roof repairs, damaged roof insulation replacement and wall insulation repair with protection for engine room exposed wall insulation.

- 1. Remove approximately 1,850 square feet of existing vinyl floor tile and carpeting. Removal will need to be coordinated with Chester Fire Chief on a room-to-room basis, to have furniture relocated for work to be completed while other areas are in use.
- 2. Replace existing flooring with Aladdin Commercial 20 mil LVT glue planks as follows:

1)	Lobby and Hall area	Approximately 440 sf	type <u>872</u>
