

CHESTER CITY COUNCIL MEETING

July 27, 2015

MINUTES

PRESENT: Mayor George Caldwell; Council Members Linda Tinker, Susan Kovas, Carlos Williams, Annie Reid, Betty Bagley, Ike McBrayer, William Killian; City Administrator Sandi Worthy; Human Resources Director Carla Roof; City Attorney Megan Gaston.

Organic Helpers – Bridget Trammel discussed her concerns with the home invasions in the Sunset Drive area and requested Council to help with revitalizing the neighborhood crime watch and have each Council ward to participate. Ms. Trammel requested that Council review this proposal.

Shelly Dominick – Semi Trucks on West End Street – Mrs. Dominick would like to know the status of the semi trucks in the city. Councilman Killian stated that we need to post signs that state “Truck Route”. Mrs. Worthy informed Council that the highway department indicated they would not place any more signs and could not place Truck Route Signs.

Frank Dominick 121 West End Street – I have concerns with the internet services provided by TruVista and the fact that our television stations are going down. TruVista continues to raise their prices and the service is poor. Sometimes you get internet service and sometimes you do not. If they are going to have an expansion of services, they need to provide decent services.

pay a large amount at one time. 86% residents in the city are on homestead with a tax of \$43.03. Much discussion took place concerning upgrades on the current tax software. After much discussion, Tinker motion not to go into an agreement with the county to collect taxes that we currently collect our own taxes. Councilwoman Tinker made a motion to rescind the ordinance that we approved 2 meetings ago. Councilman Killian seconded the motion. All in favor of the motion were Tinker, Williams, Reid, Caldwell, and Killian. All opposed were Bagley, Kovas, and McBrayer. The motion carried.
